b) SADC Local Plan

The District Council call for sites for future development deadline passed on 8<sup>th</sup> March. The Parish Council put forward a proposal for the Parish Centre site as agreed at the Full Council meeting in February, subject to ensuring alternative community facilities continue to be available in Bricket Wood. This submission included outline plans for 6 dwellings on the footprint of the Parish Centre to reflect the cottages opposite on Station Road. It recommended the barn be retained and used as business premises. The District Council will consider submissions and is expecting to make decisions about whether to include proposed sites in the Draft Local Plan in the autumn.

c) Neighbourhood Plan update

The Draft Neighbourhood Plan was agreed by Full Council at the February meeting and has been submitted to the District Council for consideration before it goes to Regulation 16 consultation.
