a. Enforcement updates

The Assistant Clerk has passed on concerns over Artel Scaffolding at Station Yard, Bricket Wood, fencing around the bunker site, a Grade II listed building and the erection of a scaffolding platform on the station yard site with the Enforcement Team at SADC. Discussion had been had with the manager of the company and they had said that the fencing around the bunker would be replaced with green mesh, that the platform was a temporary erection and that they intended to erect fencing to the yard to reduce the noise.

The 76-80 Oakwood Road application is being discussed at the SADC Planning Referrals Committee on Monday. Cllr Parry has been nominated to comment against the application on behalf of the Parish Council.
