Clear and noticeable play area signage is crucial for creating a safe, welcoming, and enjoyable environment for all users and serves several important purposes:

- Safety: One of the primary reasons for clear signage in play areas is to ensure safety. Signs communicate important safety rules and guidelines and information, such as emergency contact information, age restrictions, appropriate use of equipment and the need for adult supervision. This helps prevent accidents and injuries by ensuring that both children and adults are aware of the rules and potential hazards.
- **Promoting Positive Behaviour**: Clear signage can help promote respectful and responsible behaviour among users. This includes reminding people to keep our play areas safe and clean.
- **Branding**: Well-designed signs can enhance the overall look and feel of a play area, making it more inviting and engaging. They can also reinforce the branding of St Stephen Parish Council to help create a cohesive memorable environment throughout the Parish.

To discuss and agree wording of standard letter (below) to be issued to inform new plot holders they may need to vacate the plot should extensions and changes to the facilities be made at Greenwood Park as part of the Strategic Plan and following the outcome of the Option Study.

The plots in Greenwood Park, close to Tippendell Lane, have been the subject of rumour, conjecture, and comment for the last two years. A March 2022 petition on the change.org website claimed that it had been decided that the allotments were going to be removed, partly to create additional parking. This was an unfortunate misrepresentation of the Parish Council's early announcement that its plans to improve facilities and services to residents could affect the allotments.

Tippendell Lane Allotment Plots

Dear

The Allotments plots at the Parish Council sites are all well-established plots and the tenancy agreements contain the conditions under which they are hired.

The plots in Greenwood Park, close to Tippendell Lane, have been the subject of rumour, conjecture and comment for the last two years. All this was generated from some unfortunate misinformation from the Parish Council and exaggerated by ill-informed persons.

As a new plot-holder it is right that you should know and fully understand the position.

There are plans to rationalise the working arrangements of the parish office staff and grounds men, making their working practices more effective and efficient. This will mean relocating the bases, presently at Bricket Wood, to Greenwood Park.

At present arrangements at Greenwood Park will not provide the accommodation or space to do that, so the council have engaged an independent company to look at the needs and aspirations of the council and to carry out an Option Study which will show a variety of scenarios that meet those needs. The council will then select the most suitable one that best meets the needs of the parish, but this will not be done without the benefit of consultation with users and user groups.

We expect that there will be some changes to the buildings and to areas of land at the park as a result of the Option Study. As a result of those changes there will undoubtedly be some disruption to areas of activity and we recognise that what we do will not satisfy everybody.

It is therefore right that you should know that there is a possibility that there might be some changes to the allotments and that if you take on an allotment plot you might be required to vacate the plot in order to accommodate these changes. The council will, however, give you good notice of what is happening and the time scale involved.

2. Introduction

We do not provide outdoor water for Greenwood Park users. The two public toilets have drinking water taps. When the weather is hot, lots of children use the taps, the floor gets very wet and this incurs an additional cleaning cost to the council. In addition, the café is bombarded with request for tap water and this impacts their ability to serve customers.

3. Next Steps

It would be possible to install a lower-cost water station in this financial year.
