#### 1. Purpose

To initiate the first year of the Woodland Management Plan at Park Street Recreation Ground:

# Park Street Embankment (compartments 3a and 3b)

# Year 1 (compartment 3b):

 Restock the felled area and the former tennis court in compartment 3b with site-suited native species – subsequent maintenance (spraying in spring/summer, beat up survey and restocking)

## 2. Introduction

We propose to remove the remaining trees in the area, as they are fragile and vulnerable to wind damage, followed by replanting the site. These are:

- Approximately 25 slender Ash and Sycamore trees
- Approximately 2 larger Ash trees
- Approximately 3 Birch trees

We propose to coppice:

• Approximately 10 Hawthorn trees

We have obtained the appropriate felling licence for this section, compartment 3b, granted under the new Woodland Management Plan. Initially, the licence only permitted thinning, but we have since secured the necessary approval to proceed with clear felling and coppicing.

Our intention is to carry out the planting in February or March of this year, in collaboration with local schools. The goal is to expand the woodland area by 0.2 hectares (doubling its current size) by converting the existing grassland. We plan to plant 175 whips (approximately 875 trees per hectare). A new path will be created through the area using the old tree stems, and woodchip from the felling will be used to mulch around the newly planted trees, with any excess applied along the path.

Additionally, we aim to dig out the roots of the felled trees and create a stumpery. This feature will naturally decay over time, enhancing the biodiversity of the area. The species to be planted include dogwood, field maple, guelder rose, hawthorn, hazel, and hornbeam.

The project will be part funded through an Environmental Improvement Grant from Hertfordshire County Council.

## 3. Next Steps

We require the committee's approval to proceed with the work and to select a contractor for the felling, so that the project can commence without delay.

## 4. Financial Considerations

## 5. Carbon Implications

All tree waste will be retained on-site and repurposed throughout the area to enhance biodiversity.

The only other carbon generated will be from the machinery used to process the trees and chip the branches, limited to the capacity of the chippers.

Approve the works required and recommend contractor A to undertake the work.
