To welcome public participation in accordance with the Public Speaking Policy

One member of public previously requested to speak, having noted the previous minutes about the fence installation discussion taken urgently due to the removal of the trees and vegetation outside of Greenwood Park on the A405.

Further concerns were expressed that people will not change their behaviour by keeping dogs under control or retaining on leads as per the notices and so asked the Council to undertake a risk assessment for dogs and small children getting onto the adjoining fast roads to consider installing a fence around Greenwood Park.

A second member of the public raised concerns about the continued use of the PC car park impacting use by hirers and the damage made by the developers heavy vehicles and the repairs that will required at the tax payers cost

Ver Society and the Angling Club with the hope the Club will renew the lease
